DEAR FRIENDS AND SUPPORTERS

Let me share with you some significant moments of 2016. We continued our support to programmes, associations and individuals, with the common denominator being values such as freedom, free media, education, human rights and democracy, as well as responsibility and courage.

We believe that education changes our lives, helping us to be wiser, freer and more responsible. This is why Zdeněk and I have been financially supporting talented students at foreign universities for years – in 2016, we awarded scholarships through our family foundations for the seventh time. Over the time, you may have met our students at eighteen U.S., eleven British, two French, two German, one Dutch and one New Zealand universities. In total, 113 students received our scholarship.

In the current academic year, The Bakala Foundation awarded financial support to 47 students – 13 new ones who received the scholarship for the first time, and 34 who are continuing in their studies from previous years.

Also, our effort does not end with providing financial support: the foundation organises formal and informal meetings for the scholars on a regular basis, which has allowed us to establish and maintain personal and professional relationships with them. In autumn of last year, Zdeněk and I visited one of the "crime scenes" - Great Britain. Over two days in London and Cambridge, we met with 30 of our scholarship students. They showed us around their campuses, we discussed various social, political and study issues, and listened to their needs. We left Britain charged with new energy and belief that our scholarship programme is worthwhile and that our decision to support talents was right.

More than a year ago, we opened the Student Hub, a counselling and information centre where we organise public events several times a month and provide individual consultations to those interested in studying abroad; they may also borrow publications on admission procedures at foreign universities from our library.

We continued to support the education of prospective journalists. In 2016, they could attend two courses: a three-month course titled Achilles' Data intended for Czech students of journalism, or an international summer school titled Journey: Journalism Bootcamp.

In cooperation with The Design Museum and the Kaplicky Centre Endowment Fund, we organised a Kaplicky internship programme for graduates of architecture studies. The winner is now setting off for a three-month internship in one of the top studios worldwide – Zaha Hadid Architects in London. Through this, we give young architects a chance to work at the top architects' studios, which will help them in starting their careers.

Former president Václav Havel has always been a symbol for me – of the values on which our non-profit activity is based. Last year could truly be called Václav Havel's year: in October we commemorated his 80th birthday, in December five years passed since his death. We remember his legacy continuously – Zdeněk and I have been supporting the Václav Havel Library, and in 2016 the foundation facilitated the organisation of an exhibition of photographs commemorating the life of this significant defender of human rights.

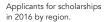
SCHOLARSHIP

The foundation has been awarding the scholarships for 7 years through its prestigious scholarship programme for talented students of high schools and universities who want to attend a complete bachelor's or master's programme at the best foreign universities and are under 33 years of age. In 2016, there were 218 applicants, of whom 123 wanted to study in Great Britain - 23 applicants stated the University of Cambridge as their first choice, 21 wanted to study at Oxford, 13 were interested in a degree from UCL, 11 from LSE and eight from King's College. Apart from Britain, we received applications for scholarships at U.S. Ivy League schools and other elite universities for instance in the Netherlands, Germany, Scandinavia or Australia.

The top 22 applicants were invited for an interview before an selection committee, and 13 were awarded scholarships.

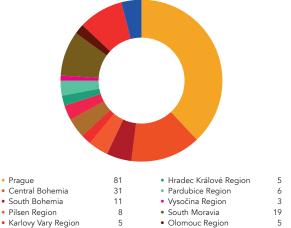
Within the scholarship programme, the foundation has already financially supported 113 students from the Czech Republic. The concrete amount of support differs depending on the school chosen and the students' financial situation. Subject to meeting the conditions, the foundation guarantees the students its support over the entire term of the study programme for which the support was granted.

In the academic year 2016/2017, 47 students received a financial contribution from The Bakala Foundation – 13 new students, who were awarded the scholarship for the first

• Liberec Region

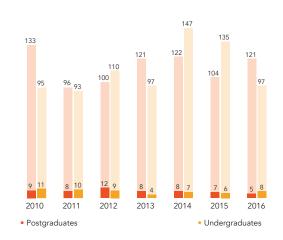

time, and 34 students who continue their studies from previous years.

The total amount with which Mr and Mrs Bakala have so far supported Czech students studying abroad has reached nearly CZK 100 million.

The scholarship programme is organised by The Bakala Foundation in cooperation with the Swiss Fondation Zdenek et Michaela Bakala.

At the end of 2015, the foundation opened in its premises a counselling and information centre for those interested in studying a complete bachelor's or master's programme abroad. Through the Student Hub, the foundation in close cooperation with scholars continuously provides applicants with necessary information, organises workshops on various topics and lectures with interesting guests, and also mediates contacts. Furthermore, the foundation offers individual consultations on various aspects of admission procedure, including help in choosing an academic programme.

but they often also ask about cultural differences and student life abroad. In 2016, a total of ten lectures were held in seven Czech towns (Hlinsko, Praha, Ivančice, Lány, Hradec Králové, Most, České Budějovice).

With the opening of the Student Hub, applicants have also been given access to a library of hundreds of volumes, where they may find information on admission procedures at foreign universities, for instance about SAT,

GRE tests or TOEFL/IELTS language exams. They can also borrow selected publication and take them home.

In the course of 2016, 19 workshops took place in the Student Hub, attended by over 500 people.

ANNUAL MEETING WITH SCHOLARS AND ELECTION OF THE PRESIDENT OF BAKALA SCHOLARS

At the end of the year, scholars regularly gather at an annual meeting. This time there were two panel discussions – first Ivan Hodač (president and founder of The Aspen Institute Central Europe) and Petr Kolář (former ambassador in Sweden, Ireland and Russia) discussed with scholars what effect Brexit and the election of Donal Trump as U.S. president may have on our lives. In the second debate, panellists Bohumil Kartous (EDUin), Michal Pěchouček (member of the foundation's board of trustees) and Jakub Tesař (Fulbright Commission) focused on what our scholars

could do to increase the quality of education in the Czech Republic.

At the annual meeting, scholars elect a president from among their midst. In 2016, Stanford University graduate Aleš Weiser was elected, replacing Ján Michalčák in the office.

KAPLICKY INTERNSHIP 2016

The programme offers recent graduates of architectural studies from Czech universities an opportunity to spend three months on an internship in one of the prestigious London studios. In this way, they may work on major projects in the company of renowned architects. In 2016, the aspiring architects competed for an internship in Zaha Hadid Architects studio in London. The winner of the Kaplicky Internship 2016 scholarship was Petra Ross from the Faculty of Arts and Architecture of the Technical University of Liberec. She gained the award for her design of the London Public Library on a prominent plot of land situated on the embankment of the river Thames near Tower Bridge.

Before announcing the winner of Kaplicky Internship 2016 competition, a debate on

the work of Zaha Hadid was held, titled "Zaha Hadid: Work and Legacy". The panellists were: Jakub Klaška of Zaha Hadid Architects, Deyan Sudjic, director of The Design Museum in London, Melodie Leung of Zaha Hadid Architects and Jakub Cigler of Jakub Cigler architects.

The programme is organised by The Bakala Foundation in cooperation with The Design Museum in London and the Kaplicky Centre Endowment Fund.

ACHILLES' DATA

A three-month course for aspiring journalists and students of journalism and media from the Czech Republic. The course aims to familiarise its participants with the basic tools, current trends and methods of in-depth journalism. In 2016, it took place for the fourth time and was attended by six teams of 3 to 4 students from Prague and Ostrava. The aspiring journalists first attend a three-day series of workshops with leading specialists on individual topics from the Czech Republic and abroad. Each of the admitted teams is then assigned a journalist - mentor, under whose guidance the teams prepare a final project on an investigative topic of their choice. The winner of the competition was the Twin Peaks team of students of the Institute of Communication Studies and

Journalism of the Faculty of Social Sciences of the Charles University in Prague, working under the guidance of Tomáš Němeček. The committee appreciated their text named "The Crime between Canvases" about a prestigious exhibition at the Prague Castle that ended up in scandal.

The course is organised by Bakala Foundation in cooperation with the Czech Centre for Investigative Journalism.

JOURNEY — JOURNALISM BOOTCAMP

An intensive summer course for talented students of journalism and media from Europe and the United States focusing on current trends in the field and practical exercise. Over ten days, top professionals from renowned media and agencies devote their time to the participants. Daylong series of workshops and lectures alternate with field practice. Students are sent to the Prague city centre to bring back real time news and reports. Mentors and lecturers supervise observance of deadlines and provide feedback. In the course, students learn how to research and analyse data and how to write and present the content of the news

reports with confidence and with respect to strict ethical standards.

In the past, we welcomed lecturers from BBC, Bloomberg, CNN, The New York Times, ProPublica, Reuters, Storyful, Mashable.com or The Wall Street Journal, including several winners of the Pulitzer price, for instance Jesse Eisinger, Seymour Hersh, Charles Ornstein or Tracy Weber.

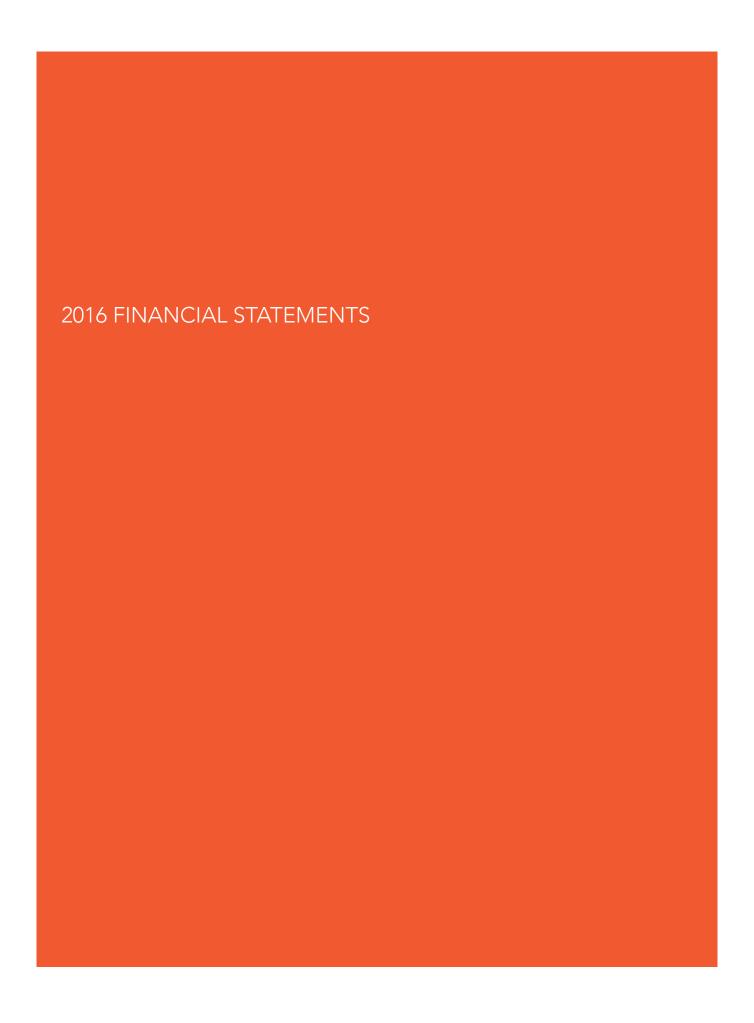

THE FOUNDATION'S MISSION:

The principal activity is to:

- a) support individuals during their studies in the Czech Republic and abroad or during their work on a thesis or scientific project;
- b) support and creation of projects in the field of education, mass media, science, healthcare, charity, sports and environmental protection;
- c) support the cultural development and arts at any social level;
- d) support the development of civil society.

The Foundation did not carry out any other activities in the given period.

Changes in the Register of Foundations

In 2016, the following changes were made:

- As of 27 April 2016, Kamil Čermák resigned from his post of a member of the Board of Trustees. This change was recorded in the Register of Foundations on 12 May 2016.
- On 27 June 2016, Melissa Maria Durda was appointed as a member of the Board of Trustees. The change was recorded in the Register of Foundations on 28 July 2016.
- On 20 December 2016, a change of the Foundation's registered office was recorded in the Register of Foundations.

2/ SIGNIFICANT ACCOUNTING POLICIES APPLIED BY THE FOUNDATION

- a) Method of keeping and processing accounting records and place of their storage

 The Foundation maintains bookkeeping in compliance with Act No. 563/1991 Coll., on Accounting, as amended, and Decree of the Ministry of Finance No. 504/2002 Coll., implementing certain provisions of the Act on Accounting, and internal policies. It also adheres to Act No. 586/1992 Coll., on Income Tax, as amended, regulating the reporting and taxation of profit or loss of non-profit organisations.

 The books are kept using the BYZNYS VR accounting software by VGD SPN, s.r.o. The accounting records are deposited at the book-keeping company's registered office.
- b) Tangible and intangible fixed assets
 Intangible and tangible fixed assets are stated at acquisition cost, which includes the purchase
 price and other costs associated with the acquisition. Tangible and intangible fixed assets that
 are reported in the balance sheet are depreciated on a straight-line basis according to the asset
 type over the appropriate estimated useful life. Fixed assets reported in Class 0 are depreciated
 in compliance with Act No. 586/1992 Coll., on Income Taxes, as amended. Other intangible fixed
 assets (website) are depreciated on a straight-line basis over 36 months.
- c) Foreign currency translation
 - The Company applies the Czech National Bank official rate to foreign currency transactions. During the year, foreign exchange gains and losses are only recognised when realised at the time of settlement.
 - As at the balance sheet date, foreign currency monetary assets and liabilities are translated at the prevailing Czech National Bank official rates. Unrealised foreign exchange gains and losses are reported in profit or loss.

d) Received and provided donations

The Foundation records funds received based on donation contracts in the "Funds" account and from this account funds are released according to their planned use or based on a request submitted by their donor as follows:

- they are transferred to the bank account of an individual or a legal entity chosen by the Board of Trustees;
- they are transferred to the income statement and credited to the Utilisation of Funds account up to the amount of expenses which have been approved by a responsible member of the Board of Trustees and which relate to project activities or the administration of the Foundation;
- they are transferred to the Foundation's capital based on a request of the donor and a decision of the Board of Trustees to increase the Foundation's capital.

The Foundation records non-monetary donations based on donation contracts in revenues (received donations) and expenses (provided donations).

In accordance with the Foundation's Statutes, administrative expenses in one accounting period should not exceed 35% of the contributions provided by the Foundation during the year. In 2016 the Foundation exceeded the limit by TCZK 269 (2015 – TCZK 2 083).

The proportion of administrative expenses exceeded the limit primarily due to the fact that the scholarship payments within the Scholarship Programme are made directly by the partner foundation FZMB seated in Switzerland while the administration linked with this programme is carried out by Nadace The Bakala Foundation. In 2016, the Foundation arranged the granting of scholarships under the Scholarship Programme with a total value of over MCZK 13. The administrative expenses amount to 10% of total contributions paid out directly or intermediated.

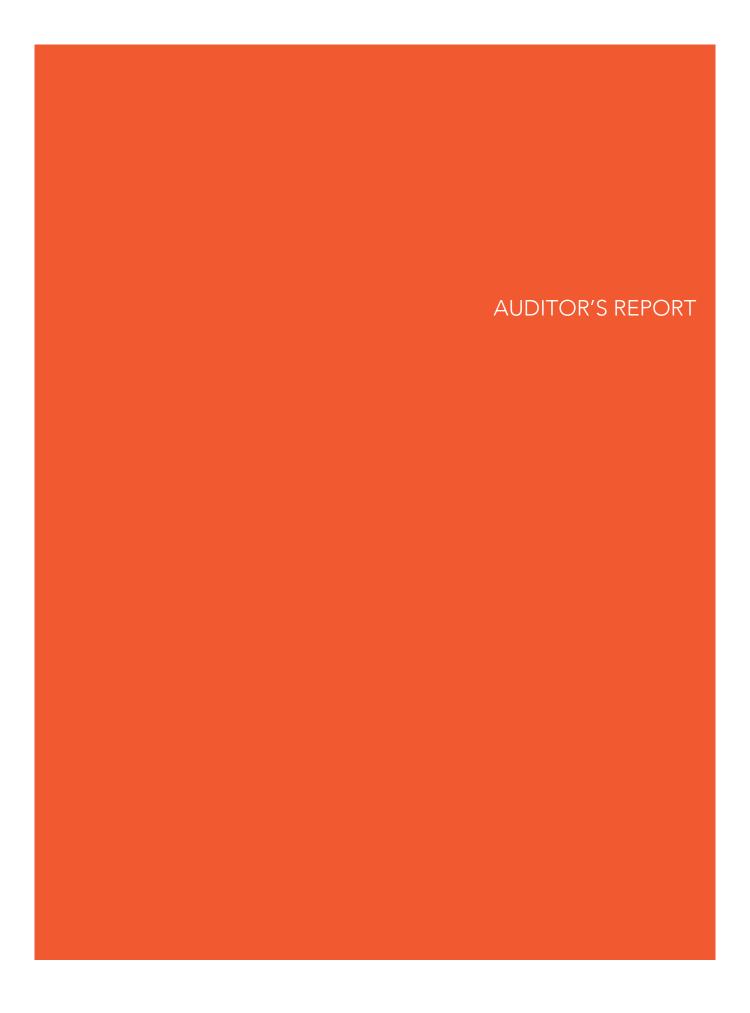
